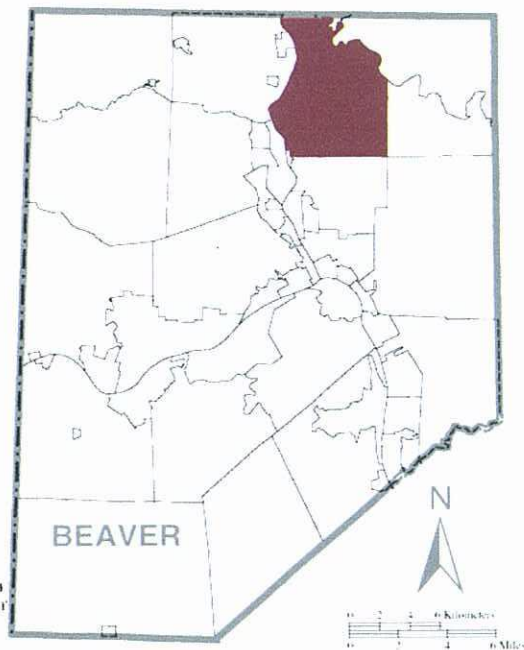

PART 1

Establishment of Municipal Authority

§1-101 SHORT TITLE

The Municipal Authority of the Township of North Sewickley.

§1-102 AUTHORITY

The authority is formed under the act of May 2, 1945, P.L. 382, as amended and supplemented.

§1-103

No other authority organized under the said act of May 2, 1945, as amended and supplemented, or by any previous act of assembly authorizing and regulating municipal authorities, is in existence in or for the incorporating municipality, the said Township of North Sewickley, County of Beaver and Commonwealth of Pennsylvania.

§1-104

The project or projects to be undertaken by said authority shall be projects permitted and authorized by the laws of the Commonwealth of Pennsylvania as The Township of North Sewickley may from time to time by resolution or ordinance specify.

PART 2

Creation of a Planning Commission

§1-201 ESTABLISHMENT

In accordance with the Act of May 1, 1933, P.L. 103, and Article XX-A, Section 2051, added 1953, July 13, P.L. 404, the Township of North Sewickley hereby creates a Planning Commission in the Township of North Sewickley, and said Planning Commission shall be known as the Township Planning Commission.

§1-202 AUTHORITY

The said Township Planning Commission shall be constituted as provided by law and shall perform all the duties and may exercise all the powers conferred upon Township Planning Commissions by law.
