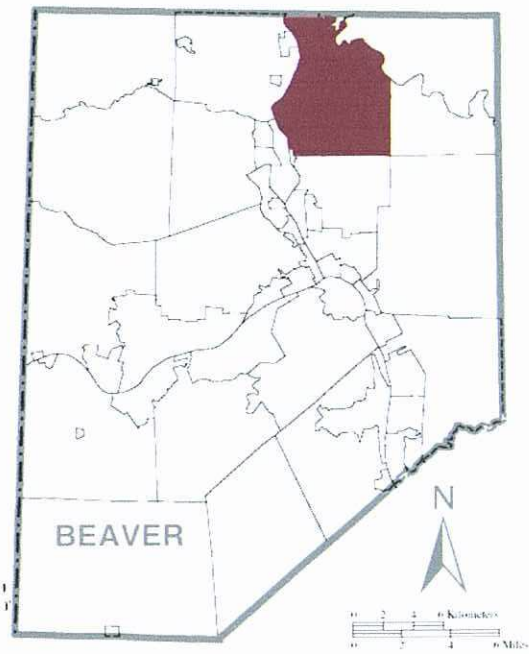

### PART 1

## Tax on Mobile Homes<sup>1</sup>

### §24-101

There is hereby imposed a tax of two dollars (\$2.00) per month on the use or occupancy of each mobile home on the use or occupancy of each mobile home suitable for living quarters situate at any place within the Township of North Sewickley, whether or not said mobile home be situate in a mobile home park<sup>2</sup>.

### §24-102
